## AMENDMENT TO THE MASTER DEED OF THE OLD SCHOOL COMMONS CONDOMINIUM

This Amendment to the Master Deed of the Old School Commons Condominium (the "Condominium") is made, signed and acknowledged this 17th day of January, 2019, by the Board of Trustees of the Old School Commons Condominium Trust who hereby certify that this Amendment is signed by Unit Owners entitled to at least *seventy-five percent (75%)* of the Voting Power of the Old School Commons Condominium Trust pursuant to Article XIII, Section 13.1 and every other power of the Master Deed dated September 5, 2003, and recorded with the Hampshire County Registry of Deeds at Book 7449, Page 1 (as previously amended, the "Master Deed").

WHEREAS, Article XIII, Section 13.1 of the Master Deed provides that the Master Deed may be amended by "vote of at least seventy-five (75%) percent of the Voting Power of the Trust, cast in person or by proxy at a meeting duly held in accordance with the provisions of the Rules and Regulations of the Condominium Trust, or in lieu of a meeting, any resolution as may be adopted in writing signed by Unit Owners constituting seventy-five (75%) percent of the Voting Power of the Trust..."

NOW THEREFORE, pursuant to the power and authority set forth in the Master Deed and M.G.L. c. 183A et. seq., the Master Deed is hereby amended as follows:

- 1. Article X, Section 10.2(b) of the Master Deed is deleted in its entirety and replaced with the following new Article X, Section 10.2(b):
- "(b) <u>Pets</u>: Pets are only permitted at the Condominium in accordance with the terms of Article V, Section 5.13(4) of the Condominium Trust and upon such terms and conditions as the Board of Trustees may implement by rule from time to time."
- 2. In all other respects, the Master Deed, as previously amended, is hereby ratified and affirmed.
