AMENDMENT TO THE MASTER DEED OF THE SUGARLOAF CONDOMINIUM

WHEREAS, the Sugarloaf Condominium (the "Condominium") was originally established by a Master Deed and Declaration of Trust and By-Laws recorded with the Franklin County Registry of Deeds at Book 7288, Page 201, and Book 7288, Page 267, respectively, as amended; and

WHEREAS, the Master Deed provides, at Section K, that it may be amended from time to time by an instrument in writing which is "signed and acknowledged in proper form for recording by at least two-thirds (2/3) of the Unit Owners..."; and,

WHEREAS, Unit Owners and the Board of Trustees desire to amend the Master Deed as set forth below;

NOW THEREFORE, pursuant to the power and authority set forth under Section K of the Master Deed and every other power in the Condominium documents and at law, the Master Deed, as previously amended, is hereby amended as follows:

1. The first sentence of Section J(10) of the Master Deed is amended to read as follows:

"Other than those Units owned by Declarant, a Unit may not be leased or rented by a Unit Owner for less than one (1) year intervals and no more than 10% of the Units within the Condominium shall be allowed to be utilized as rentals."

2. The last clause of the first paragraph of Section R of the Master Deed is amended to read as follows:

"provided said Unit Owner has complied with the Rules and Regulations of the Condominium pertaining to Solar installations, as they may be amended from time to time."

3. The last sentence of the second paragraph of Section R of the Master Deed is amended to read as follows:

"The Unit Owner shall also provide the Board of Trustees with a certificate of the contractor's insurance, in such form and amount as is reasonably satisfactory to the Board of Trustees, naming the Sugarloaf Condominium Trust as an additional insured."

4. In all other respects, the Master Deed, as previously amended, is hereby ratified and affirmed.
