AMENDMENT TO MASTER DEED OF ICE POND WOODS CONDOMINIUM

Eaton and Associates, Inc. Registered Professional Land Surveyors, 235 Russell Street, Hadley, Massachusetts and recorded in the Hampshire County Registry of Deeds at Plan Book 236, Page 16 as evidenced by that certain deed of Gordon Hall, III, Trustee of the Hall/Amherst Realty Trust, to Ice Pond Woods Condominium Association, date July 8, 2016 and recorded in the Hampshire County Registry of Deeds at Book 2655, Page 341.

The amended Appendix "A" is attached hereto and made a record hereof.

Other terms and change: All other terms of the Master Deed of the Condominium shall remain unchanged and in full force and effect, and all such other terms are hereby ratified and confirmed.

Description of Land

Being an Amended Appendix "A" to a certain Master Deed of the Ice Pond Woods Condominium dated December 16, 1974 and recorded in the Hampshire County Registry of Deeds at Book 1811, Page 153, as amended herewith.

Parcel 1

A certain parcel of land and all improvements thereon situated in the Town of Amherst in the County of Hampshire and the Commonwealth of Massachusetts, westerly of Belchertown Road and on the easterly side of Old Farm Road, being shown on a plan entitled "Master Deed Survey for Ice Pond Woods Condominium in Amherst, Massachusetts," dated June 19, 1974 by Harold L. Eaton, Registered Land Surveyor, said plan recorded in the Hampshire County Registry of Deeds at Plan Book 94, Page 56 as amended and recorded in the Hampshire County Registry of Deeds at Plan Book 94, Page 56; being more particularly bounded and described as follows:
